Capital credit payments

We will return approximately **\$922,500** in **capital credits in 2024** to members who purchased electricity in 2002 and 2003.

Instead of returning profits to investors and stockholders we return capital credits to our member-owners.

Watch for a check in the mail or a credit on your July bill. (Credits over \$75 are mailed as a check; under \$75 receives a bill credit.)

With this retirement, we will have paid out a total of \$16.2 million in capital credits to members!



What are capital credits?

1. Co-op members use electricity and pay bills.
2. At the end of the year, the co-op determines if there was a profit (margin).
3. The co-op allocates margins to members to be repaid later as capital credits.
4. If the co-op's financial condition permits, the Board of Directors determines retirement (payment) of capital credits.
5. Members receive capital credit payments.

Keep your phone number up to date



It is important that we have an accurate primary phone number for each membership. We call our members for a variety of reasons, some of which include notifications of mail being returned, a planned outage, a returned payment, a courtesy call of past-due balance, or an irrigation load control period. The primary number for the membership will be called for all accounts under that membership. Check the top right corner of a recent bill to be certain we have the correct phone number listed and notify us if an update is needed.

ENERGY EFFICIENCY TIP OF THE MONTH

Electricity used to operate major appliances accounts for a significant portion of your home energy use.

Here's an easy way to lighten the load on your clothes dryer. Before you dry a load of damp clothing, toss in a clean, dry towel. The towel will absorb excess water, shortening the drying time. If your dryer does not include an autosense feature to determine drying time, remember to reduce the timer to about half of what you normally would. Remove the towel about 15 minutes after the cycle begins. Shorter drying times will extend the life of your dryer and save energy.

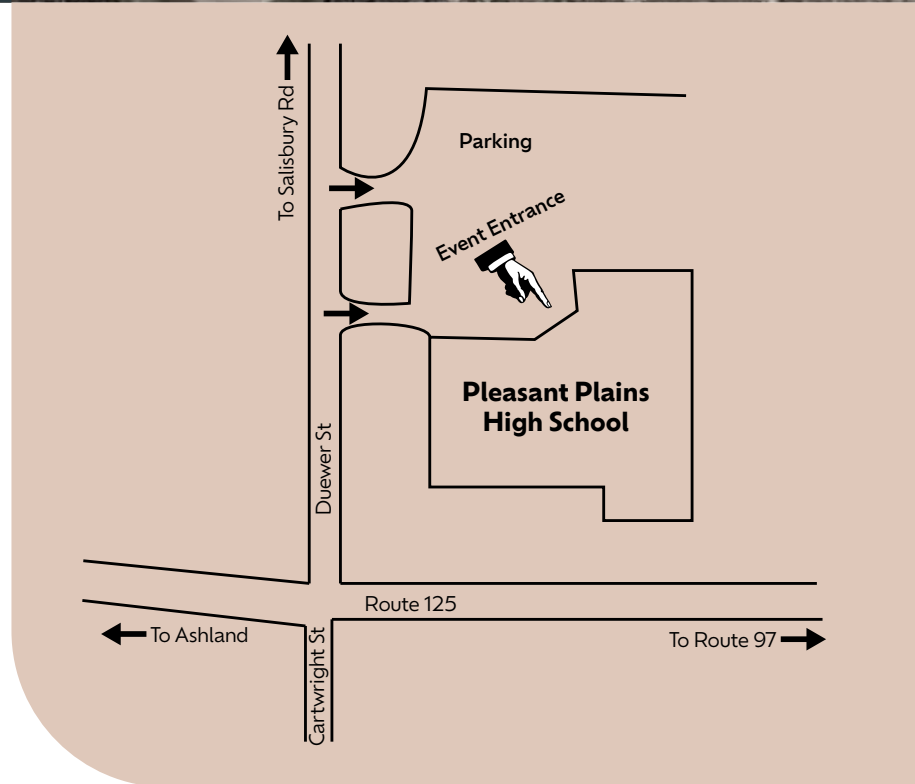
