



2025 Youth Tour

Carly DeSutter of Manito was chosen as this year's 2025 Youth to Washington ambassador for Menard Electric Cooperative. She traveled to Washington, D.C. with 48 students sponsored by 25 Illinois electric and telephone cooperatives. That group joined 2,000 students from 44 states for the annual event.

Over the course of the week, Carly visited historic landmarks including Gettysburg, Arlington National Cemetery and toured the White House, where students caught a glimpse of President Donald Trump. She also toured the U.S. Capitol, strolled the National Mall and Museum of Illusions, visited the Holocaust Memorial Museum, stood at the steps of the Supreme Court and explored the Smithsonian museums.

Midweek, Carly took part in the National Rural Electric Cooperative Association's Youth Day, where she joined hundreds of other teens from across the country to hear from national leaders and learn how to use her voice back home.

Central to the Youth Tour experience is the formation of a mock student-run cooperative called Chip 'n' Pop Co-op. Carly was chosen as co-op manager. The co-op handled snack sales and gave participants a hands-on look at how co-ops operate.

Business Meeting

The Director Election was held and members reelected Gary Holloway of Petersburg from District 1, Dennis Ryan of Petersburg from District 4, and Steve Worner of Manito from District 6. The co-op is governed by a board of directors made up of nine members, each residing in a defined director district area and elected from and by the membership to serve 3-year terms. Members approved minutes of last year's meeting.

Members approved the Treasurer's Report given by Board Treasurer Dennis Ryan. Ryan walked members through a financial statement handout highlighting the cooperative's performance during 2024.

Board President Warren Goetsch discussed the theme of the meeting, "Amplify," and the various activities of the co-op throughout the past year involving community service and member involvement. He also encouraged members to join Voices for Cooperative Power to learn more about how energy policies are affecting co-ops and ways to engage with legislators.

General Manager Alisha Anker highlighted employees' commitment to safety by announcing a safety milestone of 4+ years without an accident-related lost time incident. She said, "This milestone represents countless moments where employees chose safety over shortcuts and the well-being of the crew over individual convenience." She also highlighted the results of a recent member satisfaction survey, discussed a continued decline in average annual outage duration, and took an in-depth look at the power industry's supply chain and how distributed renewable energy fits into that chain.

Under old business, members provided questions and comments that encompassed support of vegetation management program, clarification of facility charge and criticism of changes made to distributed generation programs.
