Menard Electric Cooperative is unique because we belong to the communities we serve. We are led by our members, which gives us a unique understanding of the needs of our local communities. Because we answer to local members (that's you!) rather

than far-away shareholders, we're more nimble and able to respond quickly to the changing needs in our communities. One way we support those communities is to share excess revenues with the consumer-members we serve.

We know times are tough right now and we want as many members as possible to experience the benefits of capital credits. Both our long time and newest members will receive capital credits this year. If you had service with us in 1996 and/or 2018, look for your bill credit on this month's billing statement. We estimate that returning capital credits to the membership this year in accordance with this revised methodology will reduce the volume of unclaimed

capital credits ultimately held by the cooperative and put more dollars over-all into our active members' pockets.

Inactive members with more than \$2.50 in capital credits will receive a check. Later this year we will be asking for help to find some of these Inactive members, stay tuned for the list.

We here at Menard Electric Cooperative appreciate our members and the hard work and sacrifices each of you have made this year. We are all in this together. Rest assured the co-op continues to work hard every day to efficiently deliver the most affordable, reliable and safe energy you have come to depend on.

More about capital credits

When Menard Electric closes its books at the end of each year, after all the bills have been paid and all the expenses calculated, we plan to have a little



left over. Like all utilities, we require working capital to operate our business and provide services to our members. We reinvest that capital into our operations. Some businesses would call those leftovers their profit, but that's the cooperative difference.

Since the cooperative belongs to its members, we call the leftovers our margins and those margins are allocated back to you and eventually retired.

The amount allocated to each member is based on how much electricity they used during the year. We call the retirement of those allocations your capital credits.

Each year, the board of directors carefully analyzes the financial condition of the cooperative and authorizes capital credit retirements. When credits are returned for a specific year, they will be paid to every member who had service with us and an electric bill that year. 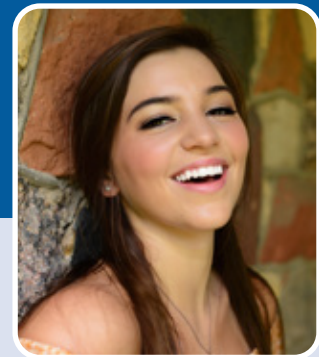
Carter Martin of Mason City

Budget Billing

Pay the same amount each month. Once a year you will “settle up” with a credit if you used less than the estimated amount of electricity, or a balance due if you used more. We’ll periodically evaluate the account and apply a one-time adjustment if needed to keep you from having a large settlement amount.

June is a great time to start!

Average Billing

This uses a 12-month rolling average to even out monthly fluctuations. We will bill a dynamic average amount that will fluctuate monthly. This option does not have a settlement month.

Pay Automatically , Choose Your Date

Sign up for Automatic Payment to process your payment through your checking or savings account on the 10th, 17th or 24th of each month. You’ll still receive a bill each month to know how much to deduct.

Sign up on the back of your payment stub this month and never worry about forgetting to pay, possible mail delays, or other payment snafus again!

Paperless Billing

It is fast and reliable to receive notification of your bill by email. You’ll receive notification as soon as your bill is ready to view. Then you can pay online, call to pay, mail your check or log the amount for automatic payment. Log onto your account through our MyMEC app or our website portal at www.menard.com and select Account Management/Paperless Options/ check mark email and paperless.

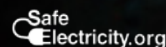


WHAT SHIMMERS And Shines

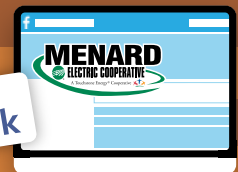
Use **SUMMER OUTDOOR LIGHTING** Safely

- Only use lighting approved for outdoor use.
- Make sure lighting has a reputable seal of approval, such as UL.
- Use outdoor-rated bulbs.
- Use recommended bulb wattage.
- Inspect all cords and lights for damage or wear before using them.
- Only use outdoor-rated extension cords and do not overload them.
- Do not use nails or metal tacks to hang light strands. Make sure your outlets are GFCI-protected and test regularly.

Employee Favorite RECIPES



Broccoli Cheese Soup

- 1/4 cup butter
- 1/2 cup diced onions
- 1 cup shredded carrots
- 2 1/3 cups broccoli florets
- 1/4 cup flour
- 1 1/2 cups chicken broth
- 1 cup milk
- 1 cup heavy whipping cream
- 1/2 teaspoon salt
- 1/2 teaspoon black pepper
- Pinch of crushed red pepper flakes
- 2 cups shredded cheddar
- Additional cheese and bacon to garnish, opt.

Melt butter in a large pot over medium heat. Add onions, carrots and broccoli. Cook 5 minutes to soften. Sprinkle flour, stir. Cook 1 minute. Add broth, milk and cream. Add salt, pepper and red pepper flakes. Continue stirring over medium heat until thick (10 to 15 minutes). Add cheddar cheese and stir until melted. Serve with crumbled bacon and shredded cheese to garnish.
